### Enhancements

- eDoc Stat Prog – A member's ID is now automatically loaded in GOLD if it exists in the iDocVault when a teller executes a transaction
- Alternate entity 1098 reporting
- Opened up CU option functionality in the management security feature
- Patronage Dividends enhancements – using new member average balances file
- Added mortgage statement indicator to member statement configurations, screen changes for generating statements – preparation for new mortgage statement in January
- Changed screen selection from months to days to reflect NCUA changes for JE calculations for int on delinquent loans
- Phase 1 and 2 for the implementation of GOAnywhere Services Software
- 40+ Links to eDoc (phase 2) – added generic ProDOC fetch/view, capture/scan links

### EFT Enhancements

- EFT Incremental Authorizations for FISERV
- Updated FISERV incremental auth functionality to appropriately release holds for non-incremental transactions.
- Updated JHA status code 05 as a warm status code, allowing for the card to be reopened at the Credit Union if appropriate.

- Updates to Control/Limit access to DEFMD

### Internal Enhancements for Self Processors

- Combined CT/SI eDoc Draft Returns with CU\*Northwest eDoc Draft returns for SITE4 operations efficiency
- Updated FIDM reporting when building a match reporting file for the state of California

### Miscellaneous

- Added date edits to print function for teller activity in MNHTLA #3

- Updated GOLD to reflect the OTB Available balance to show negative balance indicator
- Updated entry into GL to display the src#/ck#, debit, and credit properly in the GL transaction inquiry screen
- Updated Avg Prod Per Member and Avg Svcs Per Mbr to display 3 decimal positions
- Updated the legend to show Online Banking, CU mkt Opt-In, 3rd Party Opt-In and Reg E – Opt-In values in the bar chart display in MNMGMD, option 18
- Updated service charge program pop up in VIEW mode to match host in marketing club programs
- Select option on the Potential Loans to be Sold screen is now working properly
- Service Charge Programs are now updating HSABAL and IRABL properly
- Corrected date issue for BSA transactions with national shared branch transactions when job date has not been refreshed
- Updated work files from Payroll Transmission to print first detail record on report
- Eliminated running balance issue on reversal on a fee from a loan account.
- Updated the 2013 IRS Reporting file based on feedback from test files sent to the IRS. These minor changes were in the areas of record counts and combined reporting.
- Corrected the update to the IRABL file when internally transferring between IRA accounts (I code)
